**Use of Books by RFB&D Members Only**

RFB&D's audiobook library is accessible only to a qualified population of people who are RFB&D members because they have a certified print disability. Because of this eligibility requirement, RFB&D's AudioPlus™ digitally recorded books on CD are copyright-protected with a program that requires them to be played on specialized equipment. To play an RFB&D digitally recorded book on a digital playback system such as the equipment you are about to purchase, a member must "unlock" the book by entering a Personal Identification Number (PIN), which is distributed only to registered RFB&D members.

**Copyright Acknowledgment**

**The contents of all RFB&D books are protected under copyright law.** RFB&D strictly regulates the distribution of materials within a qualified member population that has provided documented evidence of a print disability. Copying, sharing or redistributing RFB&D's books in any form to any person is strictly prohibited by law and is a violation of publishers' rights. This prohibition also precludes all copying or sharing of RFB&D audiobooks with other RFB&D members or third parties. Violators may face possible civil or criminal penalties.
